## SECTION 4: FIRST AID MEASURES

### **4.1. Description of first aid measures**

Inhalation: Move into fresh air and keep at rest. Get medical attention if any discomfort continues.

Safe handling advice: Observe good chemical hygiene practices. Avoid prolonged and repeated contact with grease, particularly used grease. Always remove grease with soap and water or skin cleaning agent, never use organic solvents.

Hand protection: For prolonged or repeated skin contact use suitable protective gloves. Nitrile gloves are recommended. Thickness:  $\geq 0,38$  mm. Breakthrough time:  $> 480$  min. Other types of gloves can be recommended by the glove supplier.

Eye protection: Risk of contact: Wear goggles/face shield.

Skin protection: Wear apron or protective clothing in case of contact.

Hygiene measures: Wash hands after handling. Change contaminated clothing.
